SERVICE AND COMMUNITY

ON AUGUST 12, 2023, we will host our 84th annual membership meeting at the Ridin' the River Cowboy Fellowship outside of Bandera. This will be the first time we have had an in-person meeting since 2019. Bandera Electric Cooperative is a private, not-for-profit institution, and we employ a democratic process whereby Board members are elected each year by the membership (owners). The Board members take an active role in the governance of your electric cooperative.

Participation in the annual membership meeting reflects the importance of service and community. It is a forum where the issues facing our electric cooperative and the community are discussed. Where the informal connections between individuals rise to create the future visions of community.

Observing America as a foreigner in the first half of the nineteenth century, French philosopher Alexis de Tocqueville lauded the reliance of the American system on community rather than national government action. He explained:

"When the members of a community are asked to attend to affairs, they are necessarily drawn from the circle of their own interests and snatched at times from self-observation. As soon as a man begins to treat affairs, he begins to perceive that he is not so independent of his fellowmen as he had at first imagined, and that, in order to obtain community support, he must often lend them his co-operation" (Alexis de Tocqueville, Democracy in America, 1835).

At its core the electric cooperative is about "co-operation". We all benefit when we work together in cooperation. Our Board members are providing a service to the membership and to the communities we serve. Aristotle maintained that living in a community, or "polis," was the natural condition of man. Community based organizations, such as electric cooperatives, civic associations, and religious institutions, provide the foundational bonds which allow the community to thrive.

As a society, we are becoming more isolated from each other weakening the bonds of community and service. Voluntary private action is a vital aspect of successful community life. The Founders of our Nation recognized that we cannot expect government to solve every problem, nor did they want total government regulation of our lives. The Founders understood the connection between public and private virtues, and expounded ideas relating to both types of virtue in the Founding documents. It is through active participation in events, such as our annual membership meeting, that build stronger communities which in turn builds a stronger Nation.

2022 Annual Meeting Minutes

The Annual Meeting of the Membership of the Bandera Electric Cooperative, Inc. was held virtually via livestream from the Bandera Electric Cooperative, Inc. headquarters building in Bandera, Texas, on the 13th day of August, 2022 in accordance with the Bylaws. Chief Executive Officer Bill Hetherington welcomed members to the Annual Meeting and asked Vice Chairman Jeremy Diller give the invocation at 10:01 a.m.

General Counsel and Chief Administrative Officer John Padalino led everyone in the Pledge of Allegiance, then introuced himself. He stated that a quorum is established by receiving at least 150 ballots from members voting by mail or electronically; this year, more than 2,869 ballots were cast, so a quorum was established. Mr. Padalino called the meeting to order at 10:03 a.m. then introduced Chairman Michael Edwards, District 8 representative, to preside over the meeting.

Chairman Edwards welcomed members then introduced the Directors via video.

At 10:10 a.m., Bill Hetherington presented the CEO Report highlighting the challenges encountered in 2021 with the extreme winter weather, resurgence of COVID-19, and supply chain concerns expected to continue through the end of 2022. Hetherington stressed that BEC has not increased electric rates since 2013. He stated prudent resource management and margins generated from broadband service have allowed BEC to maintain its rates. He shared that margins in 2021 totaled \$5.4 million and the Co-op continues to see growth in electric and broadband services. Hetherington highlighted opportunities for members to participate in the Energy Saver program and discussed the expansion of broadband services into Llano, Texas.

Chairman Edwards called upon Director Solis to read the Notice of Meeting and Proof of Mailing at 10:12 a.m.

Mr. Solis read the notice of meeting then stated that the next order of business was the reading of the minutes of the Annual Meeting of the Membership held on August 14, 2021. He indicated that copies of these minutes were distributed to each Member in the annual report and entertained a motion to dispense with the reading of the minutes. A motion was made to dispense with the reading of and to approve the minutes of the Annual Meeting of the Membership held on August 14, 2021. The motion received a second and was approved by the membership at 10:14 a.m. Mr. Solis then introduced a video highlighting how BEC is helping its membership by enlightening the member experiece.

At 10:17 a.m., Chairman Edwards informed the Members of the Cooperative's 2021 Annual Report, provided via Texas Co-op Power and online, containing management and financial reports. He welcomed members who had any questions regarding the annual report to submit their questions in the online Q & A window at the conclusion of the meeting.

General Counsel Padalino returned to speak at 10:18 a.m., and he explained that three Directors are elected each year. Candidates are nominated by peition and incumbent Directors are also placed in to nominateion. No no petitions were made for candidates for the Board of Directors, and in accordance with the provisions of the Bylaws, the following incumbent persons were placed in nomination as the official candidates:

Mr. Padalino stated that votes received by the August 12, 11:00 a.m. deadline had been tabulated by Survey and Ballot Systems. The final tabulation of votes included all electronic, phone, mail-in and proxy ballots. General Counsel Padalino read the report regarding the final tally of votes for each candidate at 10:19 a.m. The votes received were as follows:

Christopher (Chris) Blakemore – 2,457 votes.

Michael D.T. Edwards - 2,508 votes.

Kurt Solis - 2,463 votes.

Mr. Padalino entertained a motion to approve the vote. A second was received, and the motion was approved by the membership at 10:20 a.m.

With no unfinished business, Mr. Padalino entertained a motion to adjourn. A motion was made, seconded, and approved by the membership to adjourn the meeting at 10:21 a.m.




